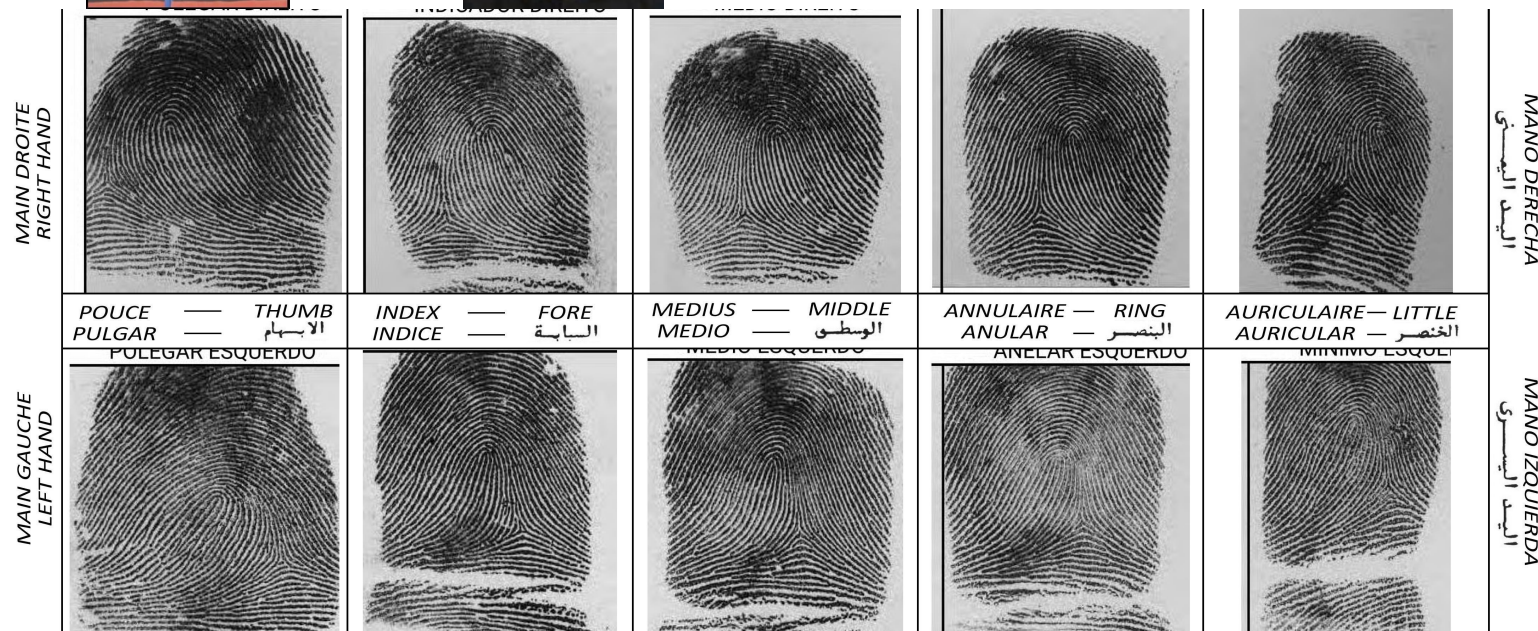

## Summary of facts of the case

On December 7, 2024, on highway BA-099, in the city of Camaçari, Bahia, Marlon Ribeiro dos Santos, together with Fábio Ribeiro, killed Larissa Pavan de Assis and attempted to kill Lais, Isys, Carlos, and Valdiney. The victims were in a Toyota Corolla, after taking a rideshare trip, when the defendants, driving a white Jeep Renegade, pulled alongside and opened fire. One shot killed Larissa, and another struck the vehicle, placing the others in imminent danger of death. Expert reports confirmed the dynamics of the homicide, and video footage located Marlon's vehicle at the scene and after the crime. The act was committed for a trivial motive and through means that hindered the victims' ability to defend themselves.
